Notice is hereby given in terms of section 17(3) of the Local Government: Municipal Finance Management Act No. 56 of 2003 and sections 74(1) & (2)(a)(b) and 75A (3) of the Municipal Systems Act No)32 of 2000 as amended by Act No 44 of 2003 that Lekwa Municipal Council at its Annual Budget meeting held on the 31<sup>ST</sup> May 2017 passed a resolution A78 approving the Budget, Tariffs, Policies, By-Laws and Tariff of Charge for 2017/2018 Financial Year, which will come into effect from the 1<sup>st</sup> July 2017.
