FIRE LEVY TO BE ADDED ON THE MONTHLY WATER AND ELECTRICITY BILL

- 1) The Fire levy will cover for fires at the structural premises (only structural fires - only Lekwa resident), the owner or owners will then not receive a bill to be paid as it will be covered by the fire levy if they proof that they are a paid-up member if not paid up, an account in regards this tariff will be sent.

2) A bill will be sent to an owner stationed in Lekwa for a veld fire occurred on his / her property due to prohibited by the Fire Brigades Services Act that no fires is allowed in the Municipal area (town), the bill is not paid up or not paid for the current month, if founded that the owner committed Arson, and faulty, or bridged, or illegal connections of electricity.

3) A bill will send to a business owner failing to adhere to all requirements set by the Building Control Officer and Fire Department, is not in position of a valid Fire Safety Occupancy certificate and also reading with point 2 above.

4) Business owners will still have to pay for fire prevention inspections and certification by which the certificate will have an expiring date.

5) A bill will be sending out to any motor vehicle accident or any incident require out payments for services delivered by the Fire Department, out payments will be required under special rescue equipment used to retrieve an animal from a sewerage pipe, mud, dam, river; and will include a bill for that in case the cost of the Municipality to the incident will reach more than R1 000.00, this will cover the expenses done by the Municipality to execute the incident except the Fire levy tariffs – monthly.
